OTHER

The Road Supt gave his monthly report on the roads, including the road patrol, no hunting signs are to be placed at Oscar's Bay Park, Rd Supt is authorized to purchase a used reclaimer to be mounted on the grader from a local contractor. Road staff is to refrain from using the council chambers and will use their upstairs office for meals and other purposes. Council is considering moving the council chambers to the 2nd storey of the Bergland hall but this may raise access issues and costs. Morson hall bathroom floor needs repairs due to water damage and pooling of water under the building. Dogs running at large at the Morson dump and other areas in the municipality continue to be a problem. Councillor Sepers reported on the public meeting to provide suitable housing in Rainy River for doctor locums. Councillors Sepers & Gate will attend the next committee meeting Nov 9 or 10 in Rainy River. Councillor Gate reported that the Recreation Committee will hold dinners on Oct 6 & 20 & craft sale Oct 27. The Mayor reported on the RRDSSAB meetings. RRFDC is seeking input on ideas on alternative uses of their tent by district municipalities. The Clerk-Treasurer's monthly report included a financial update, statistics report on the vote by mail process voter turnout was 58.6% which was down from 69.3% in 2006 and 63.1% in 2003, the joint fire chief meeting in Rainy River Oct 13, the Clerk-Treasurer provided answers to various issues raised from the recent road patrol and receipt of the pumper inspection report was received. In the election a tie between Councillors Gate & Moen was broken by the Clerk-Treasurer conducting of a lot and Councillor Moen was declared the successful candidate. A JEPP application is being submitted for radio equipment. Notice was received from AMCTO acknowledging 30 years of membership for Patrick W Giles. The township will participate in the annual emergency training & exercise in Emo Nov 17 at 7 p.m. Council reviewed the report on its priorities from 2008 and updated items completed and worked on over the period.

The Clerk-Treasurer will be on vacation Nov 15 to 24 and the office will be closed. The Mayor thanked Councillors Gate & Sepers for their service on council during this term.
