A list of questions and matters to be clarified were discussed. Does our insurance cover items such as skateboard ramps etc? Councillor Sepers concerned about lack of public notice for the public meeting to review user fees. Notice on the website and one of the 3 local publications to be used in the future, however our notice provisions were followed. The CAP computer was removed from the Bergland Café due to new owners & lack of room, a new site to be sought. Road Supt submitted his written report, he has now received a listing of contractors equipment rental rates & quote for paving the heliport (nearly \$21000), council will not proceed with paving. Council discussed the road patrol including brush on Hwy 621 & the Spruce Creek culvert. The Clerk-Treasurer is to write MTO & request the brush to be removed and the culvert to be replaced. Four hazard signs & posts were reported stolen. Potential dates for a MNR meeting on the Aulneau Peninsula Enhanced Management discussions include June 2 & 6 in Morson and in the evening. Policing cost for 2004 were \$56353 rather than estimate of \$63,012 and \$56294 estimate for 2005. OMPF funding was received and the Clerk-Treasurer will attend training on OMPF in T Bay on May 25. A Cemetery seminar will be held in T Bay June 20-21. New manual was released by AGCO & a review of charitable gaming is underway. The next RRDMA meeting will be held in Atikokan May 18. Clerk-Treasurer presented draft 2005 budget with no increase in tax rate council will discuss the budget next meeting which is to be a public meeting. There was no action taken on various resolutions.
