Work still to be completed includes signs & protection for fuel tank. Work proceeding on heliport. Bergland fire truck is being repaired for water in transfer case and a proposal to revitalize the fire department is being worked on. G Haddock to repair weather stripping on doors at both halls. Clerk gave a budget update. Council reviewed the strategic plan for public awareness for Emergency Plan. Clerk reported on 911 costs & dispatch contract, costs should be lowered with new contract. Council is taking no action in regards to authorizing the Clerk to solemnize civil marriages. Councillor Moen would like to see modifications to the website, the Clerk to look after. A couple of letters were received regarding Bergland hall with comments (positive & negative) as well as suggestions for needed changes. Council will continue to review operations of the halls.
